

## NIH Public Access Policy: Submission Methods and How to Demonstrate Compliance

	Author publishes in a journal that submits all NIH- funded final published articles to PMC; no fee.	Author requests a publisher to submit an individual NIH- funded final published article to PMC (usually for a fee). Publisher submits the final peer-reviewed manuscript to NIHMS on behalf of NIH-funded authors (no fee); NIHMS prepares manuscript for posting to PMC.

<b>Who submits the work to PMC/NIHMS?</b>	Publisher submits to PMC.	Publisher submits to PMC.	Author or third party such as a lab assistant or research coordinator (non-publisher)	Publisher submits to NIHMS. This is frequently not an automatic process, i.e., author needs to request service.
<b>What is the submission time frame?</b>	After the publisher has prepared the final published article.	After the publisher has prepared the final published article.	Upon acceptance of publication.
