

ANNOUNCEMENT TO PREQUALIFIED BIDDERS

Subject to conditions prescribed by the University of California, UC Davis Health, sealed bids for a lump-sum contract are invited from prequalified bidders for the following work:

**PROJECT NO. 9557570
DT 1ST FLR RAD NUCLEAR MEDICINE REMODEL**

Description of Work: Multi-phased department remodel to replace the three existing scanners with the latest General Electric model camera. Renovation of the space includes remodel of the existing PET/CT 1878, NUC MED 1875K, 1865J and 1865I spaces on the first floor of the Davis Tower along with control room space for each suite. The project also includes a new uptake room, housekeeping closet and infusion treatment space with 4 patient bays, a patient toilet, consult room, a prep area along with improvements to department circulation. The updated space will be served by the existing Radiology Waiting 1729. The scope of work includes, but is not limited to, non-bearing partitions, lead shielding, finishes, casework, furniture systems, equipment anchorage, floor slab cutting and patching and modification to mechanical, plumbing and electrical systems.

Prequalified Bidders must attend a **MANDATORY** virtual pre-bid conference and job walk at **1 p.m., Tuesday, November 26, 2024**. Only prequalified contractors who participate in the pre-bid conference and job walk, in its entirety, will be allowed to bid on the project. Interested participants must contact Nicole Quintero, Contracts Administrator at nicquintero@ucdavis.edu by Monday, November 25, 2024, to obtain an invitation to the meeting. Bidders must be present at the pre-bid conference no later than 10 minutes after the scheduled start time in order to bid as a General Contractor and must attend both the conference and virtual job walk in their entirety. Attendees should plan to login 5 minutes prior to the scheduled meeting start time to avoid any disruptions.

The lowest responsible bidder will be selected on the basis of the best value to the University. The objective criteria and methodology used to determine Best Value are described in the Bidding Documents. The best value to the University is the selection resulting in the best combination of price and qualifications.

Sealed Bids and Bid Bonds must be received on or before 2 p.m., Thursday, December 12, 2024, at Facilities Planning & Development, 4800 2nd Avenue, Suite 3010, Sacramento, CA 95817. Please have your **Best Value Questionnaires provided separately and submitted on or before 2 p.m., Friday, December 13, 2024, in pdf format to an upload link that will be provided by the University** to prequalified bidders who attend the entire Prebid Conference and Job Walk. Bids will be opened at a later date, after questionnaires evaluation is completed by the University. Target date for public bid opening is **Thursday, December 19, 2024, 10 a.m.**, at the same address above. If the evaluation takes longer than anticipated, we will issue an addendum changing the public bid opening date.

Bid Security in the amount of 10% of the Lump Sum Base Proposal, excluding alternates, shall accompany each bid. The surety issuing the Bid Bond shall be, on the bid deadline, an admitted surety insurer (as defined in the California Code of Civil Procedure Section 995.120)

The successful bidder will be required to have the following California contractor's license at the time of the bid opening:
"B" – General Building.

Estimated Construction Cost: \$6,680,000.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wages at the location of the work.

In addition, the University is committed to promoting and increasing participation of small business enterprises (SBEs) and disabled veteran business enterprises (DVBES) relating to all goods and services covered under the awarded agreement, subject to any and all applicable obligations under state and federal law, and University policies.
