Subject to conditions prescribed by the University of California, UC Davis Health, sealed bids for a lump-sum contract are invited from prequalified bidders for the following work:

PROJECT NO. 9557740 SESP 1P742 1P745 CT Scanner Replacement

Description of Work: Remodel of the existing class 1 diagnostic CT space 1P742 on the first floor of the surgery and emergency services pavilion (SESP), building to prepare for two new CT rooms that will receive new GE Revolution Apex CT equipment. The project also includes a new shared control area 1P740, updated patient toilet 1P741 for accessibility, updated existing reading room 1p743, updated existing dx qc 1p40b work area, update to patient dressing 1P715 and updated staff lockers 1P706. Work includes but is not limited to non-bearing partitions, lead shielding, finishes, casework, furniture system, equipment anchorage, floor slab cutting and patching, and modification to mechanical, plumbing, and electrical systems

Prequalified Bidders must attend a **MANDATORY** virtual pre-bid conference at **2 p.m.**, **Thursday**, **October 2**, **2025**. Only prequalified contractors who participate in the pre-bid conference, in its entirety, will be allowed to bid on the project. Interested participants must contact Cori Costanza, Contracts Administrator at cruggiero@health.ucdavis.edu by Wednesday, October 1, 2025, to obtain an invitation to the meeting. Bidders must be present at the pre-bid conference no later than 5 minutes after the scheduled start time in order to bid as a General Contractor and must attend the virtual prebid meeting in its entirety. Attendees should plan to login 5 minutes prior to the scheduled meeting start time to avoid any disruptions.

The lowest responsible bidder will be selected on the basis of the best value to the University. The objective criteria and methodology used to determine Best Value are described in the Bidding Documents. The best value to the University is the selection resulting in the best combination of price and qualifications.

Sealed Bids and Bid Bonds must be received on or before 2 p.m., Monday, October 27, 2025, at Facilities Planning & Development, 4800 2nd Avenue, Suite 3010, Sacramento, CA 95817. Please have your **Best Value Questionnaires** provided separately and submitted on or before 2p.m., Tuesday, October 28, 2025, in pdf format to an upload link that will be provided by the University to prequalified bidders who attend the entire Prebid Conference. Bids will be opened at a later date, after questionnaires evaluation is completed by the University. Target date for public bid opening is **Monday, November 3, 2025 at 10 a.m.** at the same address above. If the evaluation takes longer than anticipated, we will issue an addendum changing the public bid opening date.

Bid Security in the amount of 10% of the Lump Sum Base Proposal, excluding alternates, shall accompany each bid. The surety issuing the Bid Bond shall be, on the bid deadline, an admitted surety insurer (as defined in the California Code of Civil Procedure Section 995.120)

The successful bidder will be required to have the following California contractor's license at the time of the bid opening: "B" – General Building.

Estimated Construction Cost: \$2,970,000.00.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wages at the location of the work.

In addition, the University is committed to promoting and increasing participation of small business enterprises (SBEs) and disabled veteran business enterprises (DVBEs) relating to all goods and services covered under the awarded agreement, subject to any and all applicable obligations under state and federal law, and University policies.
