

ANNOUNCEMENT TO PREQUALIFIED BIDDERS

Subject to conditions prescribed by the University of California, UC Davis Health, sealed bids for a lump-sum contract are invited from prequalified bidders for the following work:

PROJECT NO. 9557750 DT10 PICU CEILING TILE & BOOM REPLACEMENT

Description of Work: Project is located at the UC Davis Medical Center in Sacramento, CA (Davis Tower), and consists of replacing twenty-four (24) existing overhead equipment booms; installing twelve (12) surgical lights in tandem with booms arms; installing wall mounted exam lights in the remaining twelve (12) locations; and installing new wall-mounted diagnostic boards in all twenty-four (24) rooms.

Prequalified Bidders must attend a **MANDATORY** pre-bid conference and job walk at **11 a.m. Tuesday**, **September 2**, **2025**, **at the Facilities Planning & Development office (4800 2nd Ave, Suite 3010**, **Sacramento**, **CA 95817**). Only prequalified contractors who participate in the pre-bid conference and job walk in its entirety will be allowed to bid on the project. Participants must arrive at or before 11 a.m. Contractor representatives arriving later than 11 a.m. will not be allowed to submit bids as prime trade contractor on the project.

Bids must be received on or before 2 p.m. Wednesday, September 17, 2025, via BuildingConnected.

Bids will be opened at **2 p.m. Wednesday**, **September 17**, **2025**, via virtual meeting. Bidders and other interested parties will receive a Teams invite from Leila Couceiro, Contracts Manager at Iccouceiro@health.ucdavis.edu.

Bid Security in the amount of 10% of the Lump Sum Base Proposal, excluding alternates, shall accompany each bid. The surety issuing the Bid Bond shall be, on the bid deadline, an admitted surety insurer (as defined in the California Code of Civil Procedure Section 995.120)

All insurance policies required to be obtained by the successful bidder shall be subject to approval by University for form and substance. All such policies shall be issued by a company rated by Best as A- or better with a financial classification of VIII or better, or have equivalent rating by Standard and Poor's or Moody's.

The successful bidder will be required to have the following California contractor's license at the time of the bid opening: "B" – General Building.

Estimated Construction Cost: \$5,500,000.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wages at the location of the work.

In addition, the University is committed to promoting and increasing participation of small business enterprises (SBEs) and disabled veteran business enterprises (DVBEs) relating to all goods and services covered under the

awarded agreement, subject to any and all applicable obligations under state and federal law, and University policies.
