

All medical care facilities are required to provide information that informs the public, patients, visitors and staff of various rights and conditions that have been put in place to create a safe medical environment. Referred to as mandated postings, the information includes postings concerning public information, warnings, and patient rights which are required for licensure of the medical facilities and its operations.

Mandated postings are to be placed in easily accessible, conspicuous locations, preferably in the building main lobby or at admissions locations within the facility.

This chapter includes a matrix of mandated postings to use as a starting point for your project. The layouts provided in this chapter are for planning purposes only. Mandated posting requirements should be coordinated with the FP&D Signage Program Representative as well as the Licensure and Accreditation Manager in the Medical and Regulatory Affairs Department of UC Davis Health to ensure that the signage plan is in full compliance prior to fabrication and installation.

A Process Unique to Mandated Postings

The implementation of Mandated Postings is handled by many departments. The Project should pay for and manage a signage vendor to fabricate the signage frame and holding device(s); Regulatory Affairs is responsible for verifying the content including employee postings; Public Affairs & Marketing is responsible for the artwork of the postings, and Plant Operations & Maintenance typically prints and installs the postings as needed when the order is not in bulk.

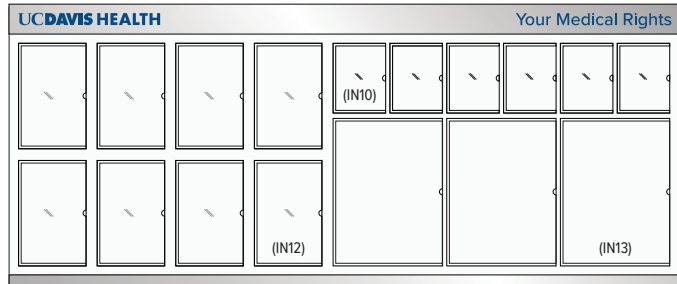

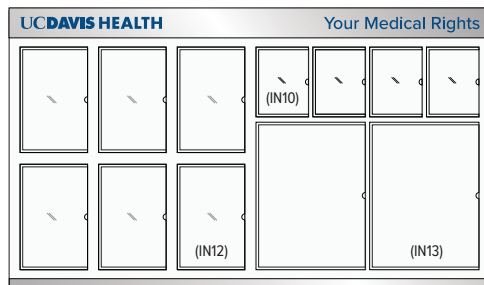

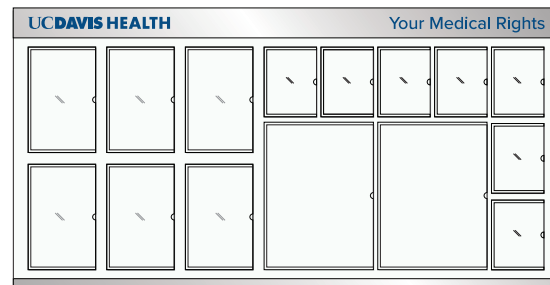
Sign Family Overview



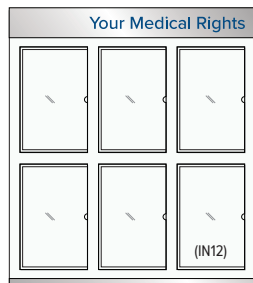

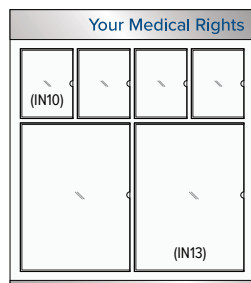

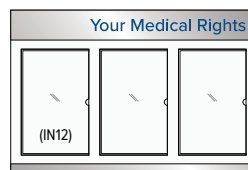

Mandated Postings

MP.01

Mandated Postings, Large

Usage

- Mandated postings are required in all medical facilities.
- Architects and designers should always plan for this largest arrangement of postings to be in a conspicuous place in the main lobby in plain view of the primary path of entry.
- **Always plan to confirm and coordinate required postings and their locations with UC Davis Health early on and often throughout the design process as these are licensure critical signs.**
- **It is advisable to include 1-2 blank insert windows to accommodate future or temporary postings as required.**

Placement

- Sign is to be placed in a conspicuous location.

Components

- (A) Backer panel: 1/8" thick acrylic painted white or other solid color to complement surrounding architecture
- (B) Frames: nonglare, scratch resistant acrylic frames of appropriate size for each required posting as detailed for sign types IN.10, IN.12, IN.13

- (C) 1/2" deep fabricated aluminum header and footer with painted finish
- (D) 1/4" thick flat cut out UC Davis logo and "Your Medical Rights", mounted flush to header panel

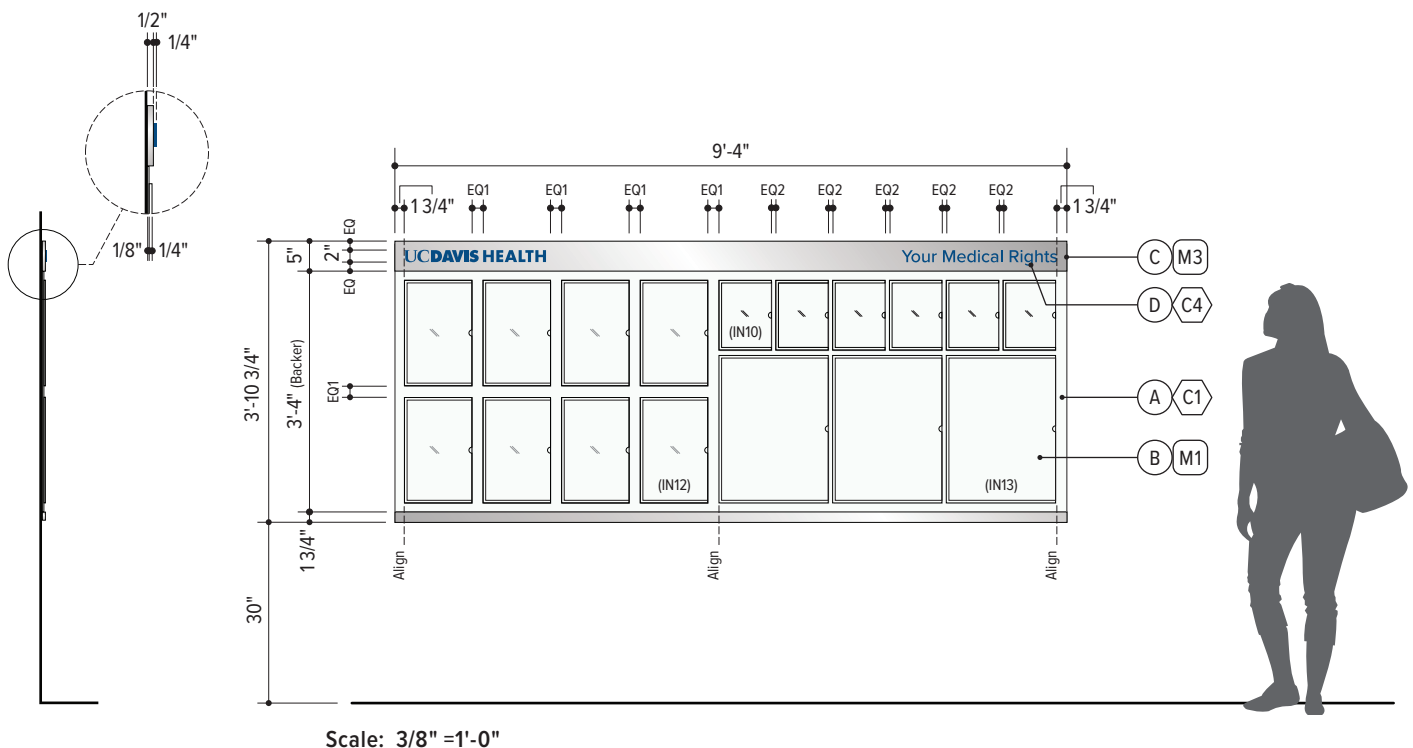

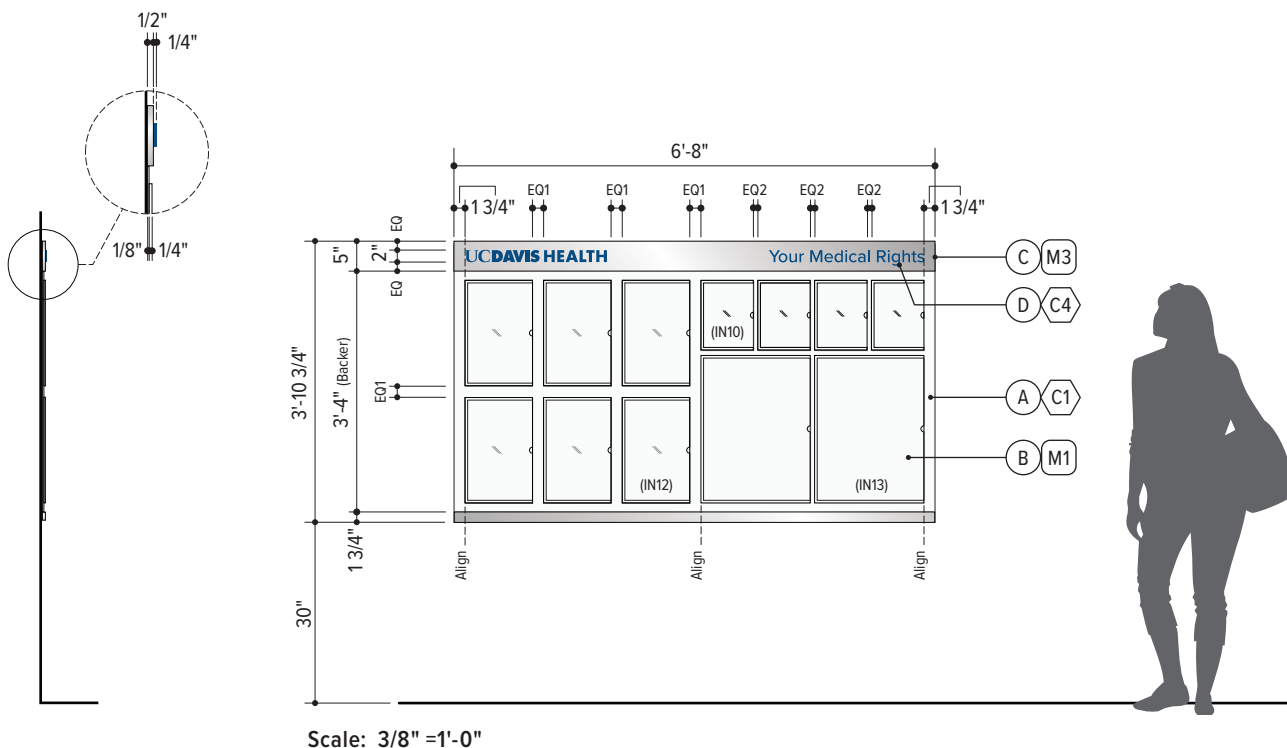

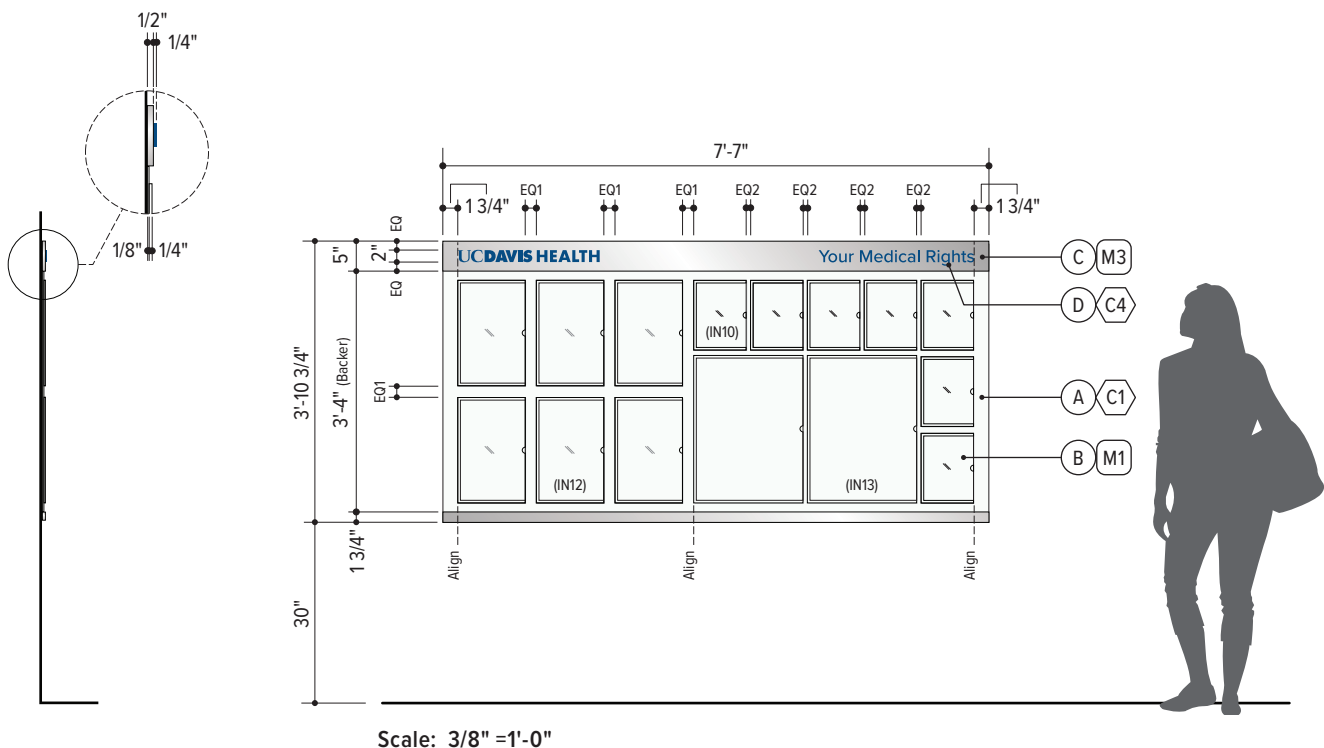
